Hendricks, County Clerk and Clerk of the Board of Supervisors of said County for and in consideration of One Dollars, in hand paid, Convey and Warrant to The Trustees of the McCord Cemetery Association and their successors in law of the Town of Irving County of Montgomery and State of Illinois the following described real estate, to wit:

A part of the west half of the South East Quarter of section Twenty Nine (29) township Nine (9) North Range Three (3) West 3 P.M. beginning at a stake twenty (20) rods [330'] north of the south east corner of said half quarter section running west sixteen (16) rods [264'] to a stake (the place of beginning) thence running north fifteen (15) rods [247.5'], thence west twelve (12) rods [198'], thence south fifteen (15) rods [247.5'], thence east twelve (12) rods [198'] to the place of beginning containing one acre and twenty rods [330'] of land more or less. The above described premises being the same land conveyed to the county of Montgomery by Elijah Paden by Warranty Deed dated August 10, 1863 and being for the purpose of a burying ground forever

situated in the County of Montgomery in the State of Illinois, hereby releasing and waiving all rights under and by virtue of the Homestead Exemption Laws of the State.
